DECLARATION

Subject: Tax Residency Status of Booking.com B.V.

To whom it may concern,

The undersigned, acting in their capacity as a duly authorised representative of Booking.com B.V., a private limited liability company established in the Netherlands, with its registered office at Oosterdokskade 163, 1011 DL Amsterdam, the Netherlands, hereby declares as follows:

1. **Tax Residency:** Booking.com B.V. is incorporated and established under the laws of the Netherlands and is a tax resident of the Netherlands within the meaning of the Convention between the Republic of Italy and the Kingdom of the Netherlands for the Avoidance of Double Taxation. 2. **Permanent Establishment:** Booking.com B.V. does not have a permanent establishment in Italy within the meaning of Article 5 of the aforementioned Convention.
